What are the main features of the Securities?

Type and class of Securities being offered and admitted to trading, including security identification numbers

Currency, specified denomination, issue size and term of the Securities

The Securities will be issued in Mexican Peso ("MXN") (the "Issue Currency") and settled in the same currency (the "Settlement Currency"). The Securities are tradable in nominal and the specified denomination per Security is MXN 100,000. The issue size is MXN 700,000,000 (the "Aggregate Nominal Amount"). The issue price is 100% of the Specified Denomination.

The issue date is 11 September 2023 (the "Issue Date"). Subject to early termination, the Securities are scheduled to redeem on 10 September 2024, (the "Scheduled Settlement Date").

Rights attached to the Securities
