#### What are the main features of the Securities?

#### Currency, specified denomination, issue size and term of the Securities

The Securities will be issued in Mexican Peso ("MXN") (the "Issue Currency") and settled in the same currency (the "Settlement Currency"). The Securities are tradable in nominal and the specified denomination per Security is MXN 100,000. The issue size is MXN 1,000,000,000 (the "Aggregate Nominal Amount"). The issue price is 100% of the Specified Denomination.

The issue date is 13 September 2023 (the "Issue Date"). Subject to early termination, the Securities are scheduled to redeem on 12 September 2024, (the "Scheduled Settlement Date").

## Rights attached to the Securities
